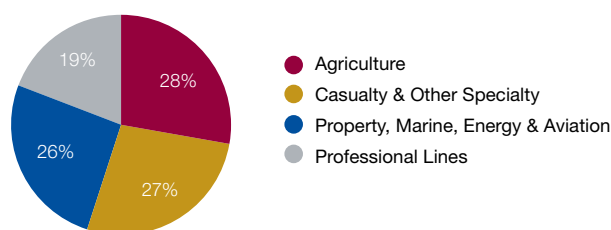

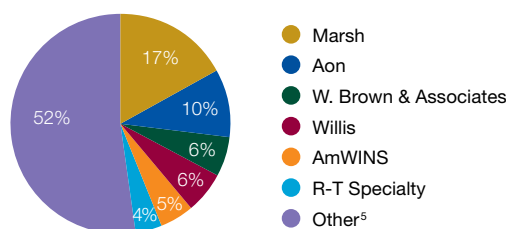

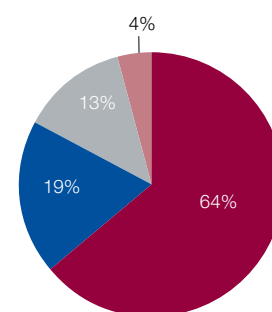
## ABOUT SOMPO
